Nomination and Admission of Junior Members

Candidate for junior membership must be 12 years of age or more at the time of application, with access to all the clubs facilities and shall be governed by the rules of the constitution of the Milton Country Club subject to the following conditions.

Until the age of 18 years the following restrictions shall apply.

- 1. No voting rights at club general meetings
- 2. A subscription rate as suggested by the committee
- 3. No right to hold office in the club
- 4. No right to nominate membership
- 5. Only Three (3) guests who are 12 years or older may be signed in on any one day
- 6. Alcohol must not be purchased or consumed on club premises except as in accordance with revisions of the Sale of Liquor Act
- 7. On reaching legal drinking age junior members must relinquish junior membership and become full members and are subject to the current subscription fee
- 8. Shall be excluded from the gaming room / playing gaming machines. Are excluded from the lucky number draw / hiring club property and all other things pertaining to the law for minors
- 9. The executive have the right to amend any rules at their discretion
- 10. Parent / Guardian MUST have signed the consent section of this application
- 11. Junior Members and Children must be vacated from Club premises by 9 pm, unless authorised by Club Management
- 12. Although Junior members are permitted on the premises of the Milton Country Club, it is not the responsibility of staff to act as supervisors
- 13. Junior members must adhere to the rules and regulations set out above and by the Staff on Duty whilst on premise
